Despite the time granted under the judgment and by the subsequent orders passed by the Tribunal, State Governments and Union Territories have not filed their comprehensive Status Report and Action Plan for compliance of the directions contained in the Judgment of the Tribunal in the case of Almitra H. Patel & Anr. Vs. Union of India & Ors. in Original Application No. 199 of 2014. There is no justification for the parties concerned and all the State Governments not to file such report.

The Learned Counsel appearing for the Central Pollution Control Board submits that they had received reports from some of the States they found serious deficiencies/shortcomings as given in para (5) and the Central Pollution Control Board has already written to the various State Governments to rectify such deficiencies and provide complete and comprehensive statements. The cut-off date/month provided was March, 2017, which is already over, however, in the interest of justice, we still grant last opportunity of two weeks for all the State Governments and Union Territories to file their Status Reports and Action Plan. All the concerned States which have filed their report to Central Pollution Control Board should rectify the defects/deficiencies as reported by Central Pollution Control Board within the same period.

We make it clear that in the event of non-compliance now, each State/Union Territory shall be liable to pay cost of Rs. 1 Lakh, which shall be recovered from the salary of the erring officers of the concerned Governments/Union Territories.

Vide our order dated 12th January, 2017, we had issued Show Cause Notice to all the State

Further, while UPcoming developing projects, industrial, residential and commercial, why directions be not issued to commence its work until and unless the development plans will provide collection, processing and disposal of municipal solid waste in accordance law and they are also to have their own sewage system plant.</p> <p>Unfortunately, till today, though more than sufficient time has expired, no reply to Show Cause has been filed except by the State of Maharashtra, State of Nagaland, Union Territory of Lakshadweep, State of Punjab, Administration of Andaman & Nicobar, State of Silckim, State of Mizoram, State of Assam, State of Bihar, State of Himachal Pradesh, State of Kerala and State of Meghalaya.</p> <p>These cases would be listed on 15th May, 2017.</p> <p>We have heard the Learned Counsel appearing for various States and Union Territories including the one who have filed their replies. facilities. These mass generators of waste are under statutory as well as corporate social responsibility to ensure that they do not throw untreated sewage, domestic/commercial waste and municipal solid waste in the open areas or in the water bodies and the Dhalaos without discharging their fundamental duties as contemplated under Article 51(a)(g) of the Constitution of India. The interest of the environment which is in a public interest must not be permitted to undermined for the commercial interest. The builders of such huge constructions should be directed to put up such facilities not only in the interest of environment and public health at large, but even at their own interest.

Therefore, we hereby direct that no plans for building of constitution over 10,000 Sq. Mtrs. area which will cover for construction of any commercial, industrial and even residential area would be sanctioned by any legal authority in the entire country unless such sanction plan duly provided for setting up of an STP which shall bring sewage and domestic discharge within the prescribed parameters. Further such plan should duly provided for a complete and comprehensive system of collection, transportation and disposal of municipal solid waste strictly in accordance with the Solid Waste Management Rule, 2016.

This direction shall apply to all the pending sanctions as of today and to all cases without exception in future.
